# •WRITE! WRITE! WRITE!


### HOW?

- Start by reading!
- Know the field
- Know the arguments/debates
- Read widely– North/South:
   East/West –
- Where do you and your work fit in
- Make sure your data is sound

# PLANNING YOUR ARTICLE



- Same with writing
- Spend some time carefully designing your paper
- What goes where



# JOURNAL ARTICLE TEMPLATE

1. Title	Make it relevant but also enticing and not too long!!! 10-15 words max!
2. Introduction	Tell the reader what the problematique is and how you are going to solve it in this paper – do the big reveal – what is your main argument and main contribution – DO NOT BE SHY!
3. Literature Review	<ul> <li>Do not call it the lit review – tell the reader what is in the section.</li> <li>Locate your study</li> <li>Set out the main debates</li> <li>Set out your conceptual framing</li> </ul>
4. Methods section	Proof that your work has voracity – give details and context
5. Data and analysis	Do not call it data and analysis – Can do both at the same time - Offer themes - Evidence claims - Signpost back to the main argument/Golden Thread
6. Conclusion	No new data/no new ideas What does it all add up to Take it back to the Golden Thread/Main argument



# **ACTUALLY WRITING**

- Loads of ways to skin a cat early morning, late afternoon,
- Things you don't necessarily need: ages and ages and ages at a time to write –
   write in the nooks and crannies
- Writing is not a luxury writing is a
   necessity do not shunt it down the list
   of priorities set time aside for it one
   hour a day/a week a whole day

• What are your top tips for writing? Either getting started or keeping up a rhythm?

### WRITING STYLE

- Check your style do not use the overly formal style of our predecessors
- Do NOT use polysyllabic word followed by polysyllabic word/Excessively verbose language... write clearly so even a non-expert can understand what you are trying to say.
- Do NOT use jargon
- Be specific do not make vague, general wafty statements – Back in the day, way back when
- Reference!
- Get someone who does not love you to read your work – then get someone who does


